

Description: ON YOUR VEHICLE, IT IS POSSIBLE FOR WATER TO ENTER THE BCM, LEADING TO CORROSION IN THE BCM.

WHEN WATER INTRUSION INTO THE BCM CAUSES LOSS OF COMMUNICATION WITH EXTERIOR LIGHTING COMPONENTS, SIGNAL LAMPS THAT ARE REQUIRED TO BE ACTIVATED WITH LOW BEAMS FRONT AND REAR SIDE MARKER LAMPS, TAILLAMPS, AND LICENSE PLATE LAMPS ARE NOT ACTIVATED. IN ADDITION, WATER INTRUSION INTO THE BCM COULD CAUSE THE SIDE MARKER AND TAILLAMP FUNCTIONS TO FLICKER AND NOT BE STEADY BURNING.

Remedy: PARTS ARE NOT AVAILABLE. FORD MOTOR COMPANY IS WORKING TO PROVIDE PARTS FOR THIS REPAIR. WHEN THE REMEDY BECOMES AVAILABLE, FORD MOTOR COMPANY WILL NOTIFY YOU VIA MAIL TO SCHEDULE A SERVICE APPOINTMENT WITH YOUR DEALER FOR REPAIRS TO BE COMPLETED FREE OF CHARGE. THE REMEDY IS ANTICIPATED TO BE AVAILABLE 1ST QUARTER OF 2026.

Glossary

CARFAX Well Maintained - Regular Oil Changes

When the first owner(s) obtains a title from a Department of Motor Vehicles as proof of ownership.
